1. Information We Collect

a. Information You Provide to Us

- Account Information: When you create an account, we collect information such as your wallet address and username. We do not collect emails or other personal identifiers.

b. Information We Automatically Collect

The platform operates independently and users are responsible for the tokens they create and mint.
- **To Provide Our Services**: We use your information to facilitate token creation, minting, and burning, as well as to process transactions.
- To Improve User Experience: Information collected helps us understand user preferences and enhance our services.

• **Security and Compliance**: Your data helps us maintain a secure environment and comply with legal obligations.

3. Sharing Your Information

a. Social Media Account Information

a. With Third-Party Service Providers
